Why do Pre-K Scholarships Matter?

Investing in early childhood education is critically important. 90% of a child's brain development happens in the first 5 years of life.

Quality early childhood education teaches critical thinking and helps children form healthy relationships. These children are significantly more likely to succeed in school and in life.

Every \$1 invested saves up to \$17 long term and generates \$1.79 in economic activity immediately.

With access to early childhood education, at-risk kids are:

- Less likely to be placed in special education and less likely to repeat grades
- More likely to graduate from high school and a post-secondary program
- More likely to become employed, economically self-sufficient adults



What is EITC?

The Pennsylvania Educational Improvement Tax Credit (EITC) program makes pre-kindergarten scholarships available to children and families throughout Bucks County.

Contributions give local kids a chance at a better education, while providing a tax benefit for participating businesses.

Once you sign up for EITC, you are able to make a donation to United Way of Bucks County for Pre-K scholarships and be reimbursed by the state through a PA state tax credit.

Who Can Participate?

Businesses that operate in the Commonwealth of Pennsylvania can claim this tax credit if they are subject to the following:

- Corporate Net Income Tax
- Capital Stock Franchise Tax
- Bank and Trust Company Shares Tax
- Title Insurance Companies Shares Tax
- Insurance Premiums Tax
- Mutual Thrift Institutions Tax
- Personal Income Tax - Subchapter s-corporations and other "pass-through" entities are able to use the credit against the shareholder, member, or partners' PA personal income taxes

How Does Your Business Benefit?

Under this program, your business may receive a PA state tax credit. Tax credits for Pre-K Scholarship Organization donations (PKSO) are as follows:

- 100% back for the first \$10,000; 90% back for additional donations, with a max of \$200,000 annually.
- Full amount of the contribution is deductible for federal tax purposes as a charitable contribution, subject to charitable contribution rules.

How Do You Get Started?

1. Visit www.uwbucks.org/eitc for direct links to forms at PA's Dept of Community & Economic Development (www.newpa.com).
2. **You must submit your online application on July 1, 2015.**
3. You will be notified when approved.

5. Make your contribution.
6. Send your acknowledgement to your tax accountant.
7. Redeem your tax credits.
