Over the past few years, that has become our mantra. Through COVID, floods, tornadoes, and more; through crises that impact the world, a community, or a single family, United Way of Bucks County is here.

Our focus is always local, our response is immediate, and our approach is holistic.

Our board and staff are a passionate and diverse group. We bring the local experience and expertise needed to get things done - and when needs in our community grow, so do we. We continue to build capacity within our own team so we can always pivot and respond.

When 100-year floods destroyed homes in Lower Bucks Coun we worked with the County of Bucks, Habitat for Humanity, and The Elevated Studio to repair and rebuild dozens of homes for low- and moderate-income homeowners. These local families are now safe, secure, and stably housed.

As refugees continue to arrive from Ukraine and resettle loca - often with nothing more than a backpack - their first stop is our HELP Center (see pages 20 and 21). Families access essential goods like clothing, personal hygiene items, food, and school supplies.

But our help doesn't end there. We work with VITA Education and Regeneration Church allowing adults to access language lessons. We work with bilingual Pre-K partners so young kids can prepare for school. And we work with our local business partners, connecting our new neighbors with open jobs.

We work locally because we are committed to building a strong, healthy, and prosperous Bucks County.

We respond immediately because that's what we would want for our own families in a crisis – and acting with urgency is one way we can show people that we respect them and that they matter.





United for Community Award ONE HOUSE AT A TIME (OHAAT)

The United for Community Award is presented to a United Way of Bucks County Member Agency or community partner who has worked effortlessly alongside our team to improve conditions in Bucks County within the last year. This award honors and recognizes the recipient's commitment to our community and their vital role in successful collaborations.

One House at a Time (OHAAT) is this year's United for Community Award winner. OHAAT's mission is to help families who are currently lacking resources to establish (or reestablish) a self-sufficient life by providing them with the necessities of a functional home environment. Through their Beds for Kids program, they provide children and youth living in poverty with beds, bedding, and tools that encourage healthy bedtime habits, so they can get the quality and sufficient sleep they need to thrive. Over the past year, OHAAT has collaborated with United Way's

HELP Center to ensure that clients have the resources they need to make their house a home – from bedding and linens to kitchenware and more. By working together, we provided 69 children with brand-new, comfortable, and clean beds in 2022. Our partnership with OHAAT exemplifies how collaborating with community partners amplifies our impact in Bucks County.



Interview with Kate Fay, Executive Director, One House at a Time (OHAAT)

In a community like Bucks County, why are collaborations important? Collaborations are key for the families and individuals who need us most. When you find yourself in the midst of a crisis it can sometimes feel like you are navigating through a bewildering forest to access the help you need. Knowing that there are effective partnerships in place to help navigate the individual needs of each situation is vital to ensuring access to the many wonderful resources that are available through our partners in Bucks County. This attention to the details, and listening to individual stories is how we show people that we truly care, and we will not let them fall

What is your favorite part of working alongside United Way of Bucks County? For me, our relationship with United Way of Bucks County embodies the true spirit of community partnership. Can you share something exciting happening at your organization right now? We are in the process of fundraising for a new delivery truck! One of the essentials we have been reliant on to make the Beds for Kids Program possible has been our trusty box truck. Unfortunately, our reliable 1997 box truck has not been so reliable in recent months. As the truck has aged each year it needs more investment to keep it on the road and running well and safely for our volunteers. We have certainly put it through its paces, but we are excited to be able to hopefully replace it soon with something much more reliable.

What is your hope for the future of our community? My hope and dream is for us to work together as a community and work through issues that might divide us to support those in crisis. In 2023 no child in our community should have to be sleeping on the floor each night. Every child deserves a bed of their own so that they can get the sleep they need to thrive. Addressing this inequity gives a child the gift not only of improved physical health, but emotional health and chances of doing well at school. We have such strength when we work together and focus on what unites us, rather than what divides us,

I have been in this community so long, I am not sure that there



OUR PROGRAMS

United for ALICE

When you're living paycheck-to-paycheck, even one financial setback can be catastrophic. UW Bucks is now piloting United for ALICE, a program that provides emergency assistance to working people who earn too much to qualify for other programs, but not enough to manage unplanned expenses.

HELP Center Shopper Referral Program

Our HELP Center serves people county-wide. It looks and feels like a retail store, full of brand-new essential items like furniture. home goods, toiletries, food, and more. But unlike a retail store, everything at the HELP Center is free to those in need.

My Free Taxes

For the 13th year, United Way is providing free tax filing software accessible through MyFreeTaxes®. Taxpayers can easily and accurately file simple federal and state tax returns for free.

Gift Card Drive

When families struggle during the holidays, there is a lot of help for young kids - but older children and teens are often overlooked. Our Holiday Gift Card Drive ensures that every young person in Bucks County has a bright holiday.

LIFT United

LIFT United (Learn to Invest in Your Future and Thrive) is a collaboration with Penn Community Bank, the County of Bucks, and Credit Counseling Center. The pilot program helps local ALICE families increase financial literacy, improve credit scores, and secure low-interest used car loans.

Bucks United Flood Recovery

Bucks United Flood Recovery (BUFR) was formed in partnership with the County of Bucks after the July 2021 floods in Lower Bucks County. The program provides emergency repairs, mold remediation, and other services to ensure that the homes of low- and moderate-income flood survivors are safe, secure, and sanitary.

Making an Impact: ALICE (ASSET-LIMITED, INCOME CONSTRAINED, EMPLOYED)



Before COVID, about 6% of Bucks County residents were living in poverty, but another 24% were ALICE (Asset-Limited, Income Constrained, Employed). We believe that number is even larger now.

ALICE is above the poverty line, but often struggles to cover the cost of basic needs. ALICE workers keep our schools, stores, and hospitals running, yet they do not earn enough to support their own families.

Unfortunately, ALICE earns too much to qualify for assistance from most programs – yet there is no room in their budget for emergencies. That's why many ALICE families are just one unexpected bill away from a financial crisis that could permanently impact their family.

UNITED FOR ALICE

United Way of Bucks County is piloting United for ALICE, a program that provides emergency assistance to working households who earn too much to qualify for other programs, but not enough to manage unplanned expenses. Our goal is to ensure that ALICE families can access the help they need.





RYAN AND FRANK'S STORY

Ryan called us on one of the coldest days of the year. He and his dad were completely out of oil to heat their home. As temperatures dropped, so did their hope. He shared their story before asking for help.

Ryan is in his mid-20s and works at a casino, making just enough to get by. His dad, Frank, was recently diagnosed with cancer, so Ryan moved in to take care of him. Frank, a senior on a fixed income, relies on a program for low-income residents to help pay his heating bills. Unfortunately, when Ryan moved in, he had to report his income, too. That put them right over the threshold for social assistance.

Out of oil and other options, Ryan called us. He said he could work overtime to afford oil going forward; he just hadn't known to budget for the unexpected bill this month. We called their oil company and had their tank filled with 100 gallons within a few hours that same day.

EMILY'S STORY

Emily reached out to us in December, right before the holidays. She had just accepted a new job with the government that had good benefits. She should have been celebrating – but instead, she was desperate and facing eviction.

Shortly before Emily received her new job offer, Emily's daughter (and her newborn and toddler) moved in. She was on

unpaid medical leave and needed somewhere to recover. Then, Emily's fiancé lost his job. Suddenly, Emily was supporting the whole household – and her new job put her just over the income limit to qualify for social support. She couldn't afford rent that month. Even though it was her first time missing a payment, her landlord was threatening eviction.

When Emily called us, we knew we had to step in. We worked directly with her landlord to provide one-time rental assistance. That was enough to help stabilize her family while she worked out a budget based on her new salary.



Making an Impact: **HELP CENTER (HEALTHY EATING & LIVING PARTNERSHIP)**



When families are barely making ends meet, affording basic household supplies is often impossible.

Located in Bristol, the HELP Center – a Healthy Eating and Living Partnership – is an 8,000-square-foot warehouse, distribution center, and shop for our gifts-in-kind program.

HELP fills the gap for local families in need by providing essentials like cleaning supplies, personal hygiene items, clothing, food, and home goods - all brand new and completely free of charge - through a dignified personal shopping experience.

The HELP Center is a collaboration between three nonprofit agencies: United Way of Bucks County, Bucks County Opportunity Council, and St. Mary Medical Center. Penn Community Bank provides generous support for the project.

ANNA'S STORY

Anna, a married mother of a two-year-old, first reached out to us for emergency food assistance. Her family was struggling; they'd just had to move in with her mother-in-law and could barely afford food. A friend recommended the HELP Center.

It was easy to see that Anna needed more than food and a tank of gas. Her son struggles with asthma and needed an air purifier and a heater for his room. She left that day with food, a gas card, and those items for her son.

We've gotten to know Anna guite well since that first call for help. Anna credits the HELP Center with helping her to regain her financial self-sufficiency. Getting what she needed to fill the gaps meant she and her family could work on building themselves back up. She says finding these essential resources in a warm and welcoming place made all the difference.

Expand both public and private support for Pre-K scholarships. Long term, this early investment gives us better-educated adults - adults who are ready to be financially self-sufficient contributors to Bucks County.





OUR PROGRAMS

Pre-K Counts

We help children get on a path to academic success by expanding early educational opportunities through the PA Pre-K Counts programs.

Through Pre-K Counts, we provide quality Pre-K education to 3and 4-year-old children at no cost to eligible families, giving our youngest neighbors a strong start in school and in life.

Private Pre-K Scholarships

Every \$1 invested in early childhood education saves up to \$17 long-term and generates \$1.79 in economic activity immediately.

That's why we provide private Pre-K scholarships to children in need through the Educational Improvement Tax Credit (EITC) and United Way funding. These flexible scholarships support working families who might not qualify for other sources of financial help.

Stuff the Bus

When a child starts school with a backpack full of the supplies they need, they can focus on what really matters – learning. Stuff the Bus, our school supply drive for children in need, gives kids the tools and confidence that they need to excel in the classroom.

Making an Impact: END HOMELESSNESS



We take a coordinated approach to preventing – and ending – homelessness in Bucks County.

Our goal is always to prevent homelessness. If we can't prevent it, we work with a strong network of community partners to ensure that in Bucks County, homelessness is a rare, brief, and one-time experience.

OUR SOLUTIONS

Ending homelessness takes a coordinated, collaborative, and community-wide approach. We invest time and money in proven solutions. We also pilot promising new programs that help address gaps in service.

WHAT'S NEXT

Increase targeted support for our most vulnerable neighbors to ensure they remain stably housed.

OUR PROGRAMS

Emergency Needs Fund

The Emergency Needs Fund helps local families with things like utilities, rent, and transportation so that a one-time issue doesn't result in homelessness.

United for ALICE

When you're living paycheck-to-paycheck, even one financial setback can be catastrophic. UW Bucks is now piloting United for ALICE, a program that provides emergency assistance



to working people who earn too much to qualify for other programs, but not enough to manage unplanned expenses.

Emergency Food and Shelter Program

EFSP provides shelter, food, and supportive services for residents experiencing non-disaster-related emergencies. UW Bucks administers this federal program locally, providing funding to eligible agencies.

Street Outreach

Locally, homelessness is nearly invisible – and therefore hard to address. Street Outreach connects with the most vulnerable people in our community and gets them on a path to stable housing.





Making an Impact: PA 211



PA 211 is a free, confidential, 24/7/365 service that connects Pennsylvanians to available resources for finding food, paying housing bills, and other essential services. Calls are answered by live professionals who are part of the PA 211 network. Individuals can also search for assistance or chat with a resource navigator online at pa211.org.

NEW TOOLS

United Way and PA 211 have implemented a new chat translation tool at **pa211.org** that allows customers to interact with 211 in 75 different languages. Individuals can connect via live chat with real-time translation – enabling the customer and agent to converse in their native languages.

PA 211 COUNTS

PA 211 continues to offer the best real-time data on the needs of individuals in our communities. PA 211 Counts (pa.211counts.org)

is a dashboard to understand these needs in counties, zip codes, legislative districts, and regions across the state.

"I wish I'd known about this years ago!"

Cheyenne stays at home to care for her daughter, who was born with a lung condition. Her husband works to provide for the family, but it's hard to make ends meet on one income. They were falling behind on rent and utility bills, and when the shutoff notice for the water arrived, she decided to reach out to 211.

She explained her situation to our Resource Navigator, who identified a few local programs that might be able to help. Not only were there programs in place to keep families like Cheyenne's from having their utilities shut off, but there were resources to help with rent, food, and other expenses.









as a percentage of Total Revenue





Each year, our Statement of Operations and Form 990 provide insight into what we raise and what we spend. They are important because they provide transparency but can be hard to understand when they are just numbers on a page.

Our total and direct investment in Bucks County is over \$7.5 million. Here is a guick guide to our major "expenditures" in 2022:

\$862,000

Monetary Investments

This covers many programs in Bucks County, like Fresh Connect, our free, mobile farmers market; Street Outreach, getting people who are experiencing homelessness on the p home; Emergency Needs, for immediate help with rent, utiliti transportation, and necessities; our HELP Center; along with other investments. Food distributed through Bucks Knocks Out Hunger, supplies distributed through Stuff the Bus, and Holiday Gift Cards for teens in need are also captured here.

Donor Directed Gifts

Locally and through the larger United Way network, we raise money that goes directly to nonprofits that make a local impact. These gifts are earmarked by the donor for a specific program or service.

\$4.5 MILLION

Community Expenditures, Including Grants

This goes to Pre-K Scholarships for low- and moderate-income families. We invest heavily in this area because this is often a family's largest expense - and it is one of the best investments we can make. Children who get scholarships to attend our high-quality Pre-K partner sites are prepared to succeed when they enter Kindergarten, giving them the best chance at longterm academic success. Plus, these scholarships mean that parents can get to work and provide for their family. Funding for the Bucks United Flood Recovery (BUFR) program is included here.

This expense covers administration costs and mandatory expenses of EFSP to ensure that funds are distributed as guickly, fairly, and efficiently as possible. In 2022, EFSP directed \$1,073,870 to Bucks County programs.

\$26,000 Program Expenses

Any additional costs to run the programs that are directly related to our mission fall into this category. Every program we invest in helps us advance our goal of creating opportunities for quality education, financial stability, and good health in Bucks County.






